REVISED ORDER

WHEREAS in terms of section 14(3)(a) / 15(3)(a) of NCTE Act, 1993, recognition was granted for M.Ed. programme of one year duration with annual intake of 25(PG) students under Clause 7(11) of NCTE (Recognition Norms & Procedure) Regulation 2007 to the institution namely "M.K. Institute of Education and Research, Vitthalprabhu Education and Charitable Trust, M.K. School, B Sardar Patel Complex, Highway Char Rasta, Patan, Gujarat – 384265 vide Order No. F.No.WRC/5-6/102nd/2008/30524-30529 dated 31.03.2008.

2. **AND WHEREAS**, the institution submitted letter dated 02.06.2015 requesting for issuance of revised order in compliance of NCTE Regulations 2014 stating that the institution submitted affidavit in this regard. However, copy of affidavit is not found attached in the file. Further institution submitted representation vide letter dated 20.06.2025 requesting for issuance of Revised Order for M.Ed. Course along with court order dated 16.05.2025 in W.P.(C) 5799/2025 & CM Appl. 26410/2025 passed by Hon'ble High Court of Delhi.

3. **AND WHEREAS**, another order dated 12.12.2025 passed by Hon'ble High Court of Delhi in contempt case filed by petitioner institution in CONT.CAS(C) 1901/2025.

4. **AND WHEREAS**, the matter was considered by WRC in its 443rd (Part-II) meeting held on 18th – 20th December, 2025, wherein the Committee decided as under: -

"The matter of the institution and related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- (i) *Recognition was granted for M.Ed. course of one year duration with an annual intake of 25 (PG) vide Order dated 15.03.2008.*
- (ii) *The institution has not submitted affidavit giving consent for conducting M.Ed. course of two years duration in consonance with NCTE regulation 2014.*
- (iii) *Revised order for M.Ed. two year duration was not issued to the institution.*

The institution filed W.P.(C) 5799/2025 & CM APPL.26410/2025 titled M K INSTITUTE OF EDUCATION AND RESEARCH & ANR. vs. NATIONAL COUNCIL FOR TEACHER EDUCATION & ANR. and Hon'ble High Court of Delhi vide its Order dated 16.05.2025 passed the following direction, the operative part of Court order is as under:

"...6. Mr. Akhilesh K. Srivastava, learned Standing Counsel appearing on behalf of the respondents states that the affidavit submitted by petitioner institution has not been received.

7. Accordingly, the petitioners are directed to submit fresh affidavit for acceptance and compliance of NCTE Regulation, 2014.

8. In the meantime, let respondents decide the request of petitioner institution for issuance of revised recognition order of petitioner institution for 50 seats expeditiously, preferably within six weeks from today.

9. In view of the above, the petition stands disposed of. Consequently, the pending application also stands disposed of."

Again, institution filed a contempt case CONT.CAS(C) 1901/2025 titled M K INSTITUTE OF EDUCATION AND RESEARCH & ANR. vs. MS RASHMI SHUKLA REGIONAL DIRECTOR WESTERN REGIONAL COMMITTEE NCTE & ANR. The Hon'ble High Court of Delhi vide its Order dated 12.12.2025 passed the following direction, the operative part of Court order is as under:

"...5. Learned counsel appearing on behalf of the respondents accepts notice and submits that the original affidavit in terms of order dated 16.05.2025 has not been submitted by the petitioners; however, they have received an e-mail regarding the same.

6. Learned counsel appearing on behalf of the petitioners submits that original affidavit will be handed over to the learned counsel for the respondents by 15.12.2025.

7. Learned counsel appearing on behalf of the respondents seeks one week's time to file a compliance report. Let a compliance affidavit be filed before the next date of hearing.

8. In case of non-compliance the concerned Officer shall remain present in the Court on the next date of hearing.

9. At request, re-notify on 23.12.2025."

The original affidavit dated 12.12.2025 received on 18.12.2025 from the institution in the office of WRC, NCTE regarding issuance of revised recognition order for M.Ed. course of two years duration with annual intake of 50 (one basic unit) as per NCTE Regulations, 2014.

In consideration of Court Order dated 12.12.2025, the Committee decided as under:

As per the direction of the Court, upon receiving the Original Affidavit dated 12.12.2025 received on 18.12.2025 from the institution in the office of WRC, NCTE, Revised Recognition Order for M.Ed. course of two years duration with annual intake of 50 (one basic unit) be issued to the institution with a copy endorsed to concerned State Government and Affiliating Body and all others concerned"

5. **NOW THEREFORE**, in light of above decision of WRC and in accordance with the provisions contained in NCTE Regulation, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to institution viz. M.K. Institute of Education and Research, Vitthalprabhu Education and Charitable Trust, M.K. School, B Sardar Patel Complex, Highway Char Rasta, Patan, Gujarat – 384265 for conducting M.Ed. course of two

years duration with an annual intake of 50 students (One basic unit) subject to fulfilment of the following conditions: -

- (i) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Western Regional Committee with required documents within 30 days from the date of issue of revised order to take further appropriate decision by WRC, NCTE in light of NCTE Act, Rules, Regulations as amended from time to time and guidelines issued by NCTE.
- (ii) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Western Regional Committee in proof of having provided additional facilities on or before 30 days from the date of revised order. Building Completion Certificate (BCC) may be given along with other documents.
- (iii) The Western Regional Committee shall arrange for verification of documents and check adherence to these conditions by the stipulated period mentioned above. If it is found by the Western Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2026-2027.
- (iv) In case any existing institution's matter is sub-judge under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the

end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

8. The institutions shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- a. Sanctioned programmes along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter;
- d. Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

This revised order has been issued in continuation of recognition order dated 31.03.2008 issued to the institution.

The above decision taken by WRC is hereby communicated with direction to the institution that the reply shall be submitted supported with requisite documents and affidavit within 30 days from the date of issue of revised order.
